CORRIGENDUM

In continuation of this office Notification of even no. dated 01-09-2026, regarding amendments/corrections in the Fee Structure notified vide Notification of even no. dated 10.04.2026, the following corrections shall be made in the said revised Fee Structure:

1. **Sr. No. 6:** The fee under B.Ed., CDOE/ICDEOL (Year-wise), which was inadvertently omitted in the aforesaid Notification, shall be read as under:
(i) Regular – ₹3,600/- Annual
(ii) Private – ₹4,500/- Annual
2. **Sr. Nos. 15, 20, 21, 22, 29 and 30:** The entry presently mentioned as "PP/PF" shall be read as "PF/PP".
3. **Page No. 02, Sr. No. 8 & 9** deleted.
4. **Page No. 4, Sr. No. 49 (C):** The entry "After 03 years additional ₹3,000/- will be applicable" shall be read as "After 03 years additional ₹2,700/- will be applicable."
5. **Sr. No. 55, Page No. 4:** The candidate who found guilty during the examination by the invigilator/Centre Superintendent/Flying squad Team. Such candidate shall be required to pay a fine of Rs. 500/- (PP) after the settlement of their UMC cases by the EDC during filling up of their examinations form again.

The above corrections shall form part of the revised Fee Structure notified vide Notification dated 01.09.2026.

All other contents, terms and conditions of the aforesaid Notification shall remain unchanged.

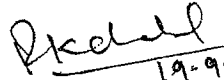
